# Public Hearing - Local Law #1, 2020, 2% Tax Cap

MOTION by Trustee Manicki and seconded by Trustee Prucnal, to leave the regular meeting and enter into the Public Hearing for Local Law#1-2021, 2% Tax Cap. 7:35 pm. On the question – no comment, 5 ayes, Carried.

# A local law authorizing a property tax levy in excess of the limit established under General Municipal Law section 3-c by the Board of Trustees of the Village of Alden.

It is the intent of this local law to allow the Board of Trustees of the Village of Alden to adopt a budget for the fiscal year commencing June 1, 2021 that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law section 3-c.

The purpose of this local law is to provide flexibility for the Board of Trustees and to protect both the Village and the residents from any actions of the State of New York.

The board is not anticipating exceeding the tax cap, but need to protect themselves if they cannot stay under the cap. They can repeal the local law if it is not necessary.

Mark Casell – 13400 Baxter Ave. – what is the actual %?

Trustee Manicki – it is given to us by the Comptroller. Property **tax** levy growth for local governments will be capped at 1.56 percent for **2021**, according to State Comptroller Thomas P. DiNapoli.

CEO – was approached by Matt Gold – Alden Community Church and Louis Backlas, owner of the Cross Over the Line Rodeo Company LLC, about having the rodeo at the church every

Saturday from Memorial to Labor Day. CEO and Attorney are discussing licensing requirements and permits but will need board approval. Matt Gold – we have 72 parking spots at the church and parking on the grass. Should be no issues with parking. Backlas – we bring our own security people, but never had an issue, we carry a \$1 million liability policy, it is on private property, so should not be a liability to the village. Creekside Septic will provide port-a-potties, food vendors are portable and are looking to be done before dark. Mary Refermat – 13611 Broadway, no problem, Gold will speak with the other neighbors, safety is our top priority. CEO – do we need a Public Hearing?

Backlas – our home base is Gainsville, but love Alden, great response, welcoming everyone is very nice. Faith based, ask for donations as opposed to charging admittance fee. Good role model for kids. CEO -reason for relocation from Alden Lanes in the Town of Alden? Backlas – owner wants to enjoy summer, as he works the rest of the year. Can we come back to the next meeting for approval? Mayor Warmus – we will put you on the next agenda. CEO – do we need a Public Hearing? Town required a special use permit.

Mark Casell - 13400 Baxter - had noise complaints when at the bowling alley. Gold – will send letters to all the neighbors.
