The Community Development Block Grant (CDBG) program is a flexible program that provides communities with resources to address a wide range of unique community development needs. The NYS CDBG program provides financial assistance to eligible cities, towns, and villages with populations under 50,000 to develop viable communities by providing decent, affordable housing, and suitable living environments, as well as expanding economic opportunities, principally for persons of low and moderate income. This grant is designated to be used on the south side of Broadway (Elm St., Kellogg St., and Mechanic St.)

The mayor recommended not submitting a project for this year. We are hoping to receive a WIIA grant for our lift stations, which would pay 25%, but we would have to pay the remaining 75%. We will also be transitioning to a new DPW Superintendent. The mayor would rather see the board wait till next year. That would give us more points if we don't submit for another year.

When we do submit it would be for Kellogg St. reconstruction.

Disconnection from the system is to be done in only the rarest of circumstances in light of the negative impacts that such disconnection will have with respect to other users.
