Request for sealed bid Village Streets Paving Project (2025)

Overview:

The Village of Alden is planning to make pavement improvements to select streets within the Village of Alden.

The work will involve milling the existing pavement and placement of a new layer of asphalt over the milled surface.

Work will begin after June 26, 2025, and must be completed no later than August 15, 2025. The exact date of the project work needs to be coordinated with the Superintendent of Public Works at avoid any conflicts with other Village projects.

Project Location:

Emerson St. (headed North) from just North of Broadway to Park St. approx.32' wide by 1020' length.

Irving St. (headed east) from Emerson St. to just west of Crittenden Rd. approx. 33'wide by 528'length.

Irving St. (headed east) from 10' east of Crittenden St. to 30' East of Wescott St. 22'wide by 573'length.

Requested Proposal: Milling and Paving

Bids are requested to provide labor and equipment for milling and paving the existing asphalt surface for the above-mentioned streets.

The milling and paving of the existing pavement will be contracted, coordinated, and overseen by the Village of Alden.

The average milling depth shall be 1.5 inches, All black top aprons will be milled and matched 1'6" where applicable.

The milling depth in the section of Irving between Crittenden and 30' east of Westcott shall be milled to the depth of 4.0 inches and paved last with 2.5 inches of binder and 1.5 inches of top, to give the village ample time to spot repair soft-spots (see alternate bid request).

Proposals are requested for the placement of new material, including tack coat, leveling and compacting the placed materials.

The proposal should include the cost of equipment, including paving machines, rolling compactors, and any other equipment deemed necessary for the task.

Furthermore, proposals must include all labor costs, reflecting current Prevailing Wage requirements.

The Village will pay for the asphalt directly so do not include that in the quote, but you must provide an estimated amount of asphalt you would require the Village of Alden to provide.

All millings will remain property of the Village of Alden-DPW and will need to be delivered to the Village of Alden yard located at 1750 Meadow drive.

Base Course / Sub-Base Course "soft-spot repairs"

Based upon prior engineering and street bores, the Village is anticipating areas of soft-spots which will need repairs and will not be able to be identified until streets are milled (but prior to paving).

The Village is requesting a bid price from bidders to identify (under the direction of Superintendent of Public Works), potential soft-spot areas in need of repair prior to paving.

Bidders are asked to provide a unit price per cubic-yard, to undercut and remove existing soft-spots, and backfill repair with road fabric and compacted #2-crusher-run.

Bids should be in two parts, one for milling & paving; and second for Base Course / Sub-Base Course "soft-spot repair".

A contract must be provided and executed by the successful bidder by June 16, 2025, for the Village Mayor's signature.

Although we will not be requiring a Bid Bond or Performance Bond, the Village of Alden will hold in retainer 5% of the contract price for one (1) year after work is completed. Said retainer will be released upon satisfactory inspection of the work after the first year of usage.

The Village of Alden reserves the right to reject the "base course / sub-base course "soft-spot repairs" and do the repairs in-house and bidders will be required to coordinate with the Village to make sure they have ample time to complete such repairs, prior to paving commencing.
